***Mark Scheme***

Mark schemes are prepared by the Principal Examiner and considered, together with the relevant questions, by a panel of subject teachers. This mark scheme includes any amendments made at the standardisation meeting attended by all examiners and is the scheme which was used by them in this examination. The standardisation meeting ensures that the mark scheme covers the students' responses to questions and that every examiner understands and applies it in the same correct way. As preparation for the standardisation meeting each examiner analyses a number of students' scripts: alternative answers not already covered by the mark scheme are discussed at the meeting and legislated for. If, after this meeting, examiners encounter unusual answers which have not been discussed at the meeting they are required to refer these to the Principal Examiner.

It must be stressed that a mark scheme is a working document, in many cases further developed and expanded on the basis of students' reactions to a particular paper. Assumptions about future mark schemes on the basis of one year's document should be avoided; whilst the guiding principles of assessment remain constant, details will change, depending on the content of a particular examination paper.

## Generic Introduction for AS

The AS History specification is based on the assessment objectives laid down in QCA's GCE History subject criteria and published in the AQA specification booklet. These cover the skills, knowledge and understanding which are expected of A Level students. Most questions address more than one objective since historical skills, which include knowledge and understanding, are usually deployed together. Consequently, the marking scheme which follows is a 'levels of response' scheme and assesses students' historical skills in the context of their knowledge and understanding of History.

The levels of response are a graduated recognition of how students have demonstrated their abilities in the Assessment Objectives. Students who predominantly address AO1(a) by writing narrative or description will perform at Level 1 or Level 2 depending on its relevance. Students who provide more explanation – (AO1(b), supported by the relevant selection of material, AO1(a)) – will perform at high Level 2 or low-mid Level 3 depending on how explicit they are in their response to the question. Students who provide explanation with evaluation, judgement and an awareness of historical interpretations will be addressing all 3 AOs (AO1(a); AO1(b): AO2(a) and (b) and will have access to the higher mark ranges. AO2(a) which requires the evaluation of source material is assessed in Unit 2.

Differentiation between Levels 3, 4 and 5 is judged according to the extent to which students meet this range of assessment objectives. At Level 3 the answers will show more characteristics of the AO1 objectives, although there should be elements of AO2. At Level 4, AO2 criteria, particularly an understanding of how the past has been interpreted, will be more in evidence and this will be even more dominant at Level 5. The demands on written communication, particularly the organisation of ideas and the use of specialist vocabulary also increase through the various levels so that a student performing at the highest AS level is already well prepared for the demands of A2.

#### **General Guidance for Examiners (to accompany Level Descriptors)**

---

#### **Deciding on a level and the award of marks within a level**

It is of vital importance that examiners familiarise themselves with the generic mark scheme and apply it consistently, as directed by the Principal Examiner, in order to facilitate comparability across options.

The indicative mark scheme for each paper is designed to illustrate some of the material that students might refer to (knowledge) and some of the approaches and ideas they might develop (skills). It is not, however, prescriptive and should only be used to exemplify the generic mark scheme.

When applying the generic mark scheme, examiners will constantly need to exercise judgement to decide which level fits an answer best. Few essays will display all the characteristics of a level, so deciding the most appropriate will always be the first task.

Each level has a range of marks and for an essay which has a strong correlation with the level descriptors the middle mark should be given. However, when an answer has some of the characteristics of the level above or below, or seems stronger or weaker on comparison with many other students' responses to the same question, the mark will need to be adjusted up or down.

When deciding on the mark within a level, the following criteria should be considered *in relation to the level descriptors*. Students should never be doubly penalised. If a student with poor communication skills has been placed in Level 2, he or she should not be moved to the bottom of the level on the basis of the poor quality of written communication. On the other hand, a student with similarly poor skills, whose work otherwise matched the criteria for Level 4 should be adjusted downwards within the level.

Criteria for deciding marks within a level:

- The accuracy of factual information
- The level of detail
- The depth and precision displayed
- The quality of links and arguments
- The quality of written communication (grammar, spelling, punctuation and legibility; an appropriate form and style of writing; clear and coherent organisation of ideas, including the use of specialist vocabulary)
- Appropriate references to historical interpretation and debate
- The conclusion

**Question 1**

**01** Explain why Luther issued the Ninety-five Theses in 1517. (12 marks)

*Target AO1(a) AO1(b)*

**Generic Mark Scheme**

Nothing written worthy of credit. **0**

**L1:** Answers will contain either some descriptive material which is only loosely linked to the focus of the question or some explicit comment with little, if any, appropriate support. Answers are likely to be generalised and assertive. The response will be limited in development and skills of written communication will be weak. **1-2**

**L2:** Answers will demonstrate some knowledge and understanding of the demands of the question. They will **either** be almost entirely descriptive with few explicit links to the question **or** they will provide some explanations backed by evidence that is limited in range and/or depth. Answers will be coherent but weakly expressed and/or poorly structured. **3-6**

**L3:** Answers will demonstrate good understanding of the demands of the question providing relevant explanations backed by appropriately selected information, although this may not be full or comprehensive. Answers will, for the most part, be clearly expressed and show some organisation in the presentation of material. **7-9**

Answers should include a range of reasons as to why Luther issued the 95 Theses in 1517.

Students might include some of the following factors:

- Luther rejected the theological basis of the sale of indulgences
- his theological objections to the sale of indulgences were reinforced by his disgust at the sales techniques of Johannes Tetzel

- his disgust at the sales technique was sharpened by the perception that the sale of indulgences was, in effect, a way of fleecing the poor and that, by conniving in this, the Church hierarchy was behaving corruptly
- the timing of the issue of the 95 Theses, on All Saints' Eve, 31 October 1517, was determined by the expectation that large numbers of pilgrims would be visiting Wittenberg to view the relics in the collection of the Elector Frederick the Wise
- All Saints Day was when the dead were especially remembered and indulgences then in demand.

To reach higher levels, students will need to show the inter-relationship of the reasons given. For example, students might make a clear link between the theological and moral objections to the sale of indulgences.

**Question 1**

- 02** How important was Luther's personal contribution to the spread of Lutheranism in the years 1521 to 1531? (24 marks)

*Target: AO1(a), AO1(b), AO2(b)*

- L1:** Answers may either contain some descriptive material which is only loosely linked to the focus of the question or they may address only a part of the question. Alternatively, there may be some explicit comment with little, if any, appropriate support. Answers are likely to be generalised and assertive. There will be little, if any, awareness of differing historical interpretations. The response will be limited in development and skills of written communication will be weak. **1-6**
- L2:** Answers will show some understanding of the focus of the question. They will either be almost entirely descriptive with few explicit links to the question or they may contain some explicit comment with relevant but limited support. They will display limited understanding of differing historical interpretations. Answers will be coherent but weakly expressed and/or poorly structured. **7-11**

Students should be able to make a judgement by addressing the focus of the question and offering some balance of other factors or views. In 'how important' and 'how successful questions', the answer could be (but does not need to be) exclusively based on the focus of the question.

Factors suggesting that Luther's personal contribution was vital might include:

- his resolute stance at the Diet of Worms in 1521
- his quelling of radicalism in Wittenberg in 1522–1523
- the importance of publications, such as the German New Testament
- the importance of Luther's role as a preacher.

Factors suggesting the importance of other reasons might include:

- the contribution of other reformers, especially Philip Melancthon's drawing up of the Confession of Augsburg
- Luther's unwillingness to reach a compromise with Zwingli, thereby ensuring the continuation of divisions amongst the reformers
- the political assistance of rulers such as Frederick the Wise and Philip of Hesse
- the importance of printed propaganda, including woodcuts
- the competing demands upon the resources of the Emperor.

Good answers are likely to show awareness that there were a multiplicity of related factors which contributed to Lutheran success and will support the factors with an appropriate range of evidence.

**Question 2**

- 03** Explain why new religious Orders emerged within the Catholic Church in the years to 1540. (12 marks)

*Target: AO1(a), AO1(b)*

- L1:** Answers will contain either some descriptive material which is only loosely linked to the focus of the question or some explicit comment with little, if any, appropriate support. Answers are likely to be generalised and assertive. The response will be limited in development and skills of written communication will be weak. **1-2**
- L2:** Answers will demonstrate some knowledge and understanding of the demands of the question. They will **either** be almost entirely descriptive with few explicit links to the question **or** they will provide some explanations backed by evidence that is limited in range and/or depth. Answers should include a range of reasons as to why New Orders developed, especially in northern and central Italy.

Students might include some of the following factors:

- there is clear evidence of a rising spirituality, particularly with individuals such as Gaetano di Thiene, which expressed itself in the foundation of new Orders
- there was an increasing perception that traditional monasticism was no longer able to satisfy spiritual needs
- there was a willingness amongst wealthy patrons to support the orders' spiritual aims
- there is clear evidence that the foundation of some orders was a response to the social misery which characterised parts of Italy in the 1520s
- in some respects the orders represented a response to the challenges posed by Protestantism
- supported by the papacy.

To reach higher levels, students will need to show the inter-relationship of the reasons given. For example, they might link increasing spirituality with an increasing level of social consciousness.

**Question 2**

- 04** How important was Ignatius Loyola to the movement for Catholic reform in the years 1540 to 1564? (24 marks)

*Target: AO1(a), AO1(b), AO2(b)*

**Generic Mark Scheme**

- Nothing written worthy of credit. **0**
- L1:** Answers may either contain some descriptive material which is only loosely linked to the focus of the question or they may address only a part of the question. Alternatively, there may be some explicit comment with little, if any, appropriate support. Answers are likely to be generalised and assertive. There will be little, if any, awareness of differing historical interpretations. The response will be limited in development and skills of written communication will be weak. **1-6**
- L2:** Answers will show some understanding of the focus of the question. They will either be almost entirely descriptive with few explicit links to the question or they may contain some explicit comment with relevant but limited support. They will display limited understanding of differing historical interpretations. Answers will be coherent but weakly expressed and/or poorly structured. **7-11**

Factors suggesting that the contribution of Ignatius was important might include:

- the *Spiritual Exercises* had an influence which went way beyond the ranks of the Jesuits
- he was largely responsible for the foundation of the Jesuits, thereby enabling him to contribute considerably to the success of Catholic renewal
- his charismatic leadership of the organisation did much to ensure that it was in the vanguard of the movement for Catholic reform
- his emphasis on education and his social concerns helped reinforce the popularity of the movement
- his personal authority and cultivation of aristocratic patrons assisted reform.

Factors suggesting other reasons might include:

- the contribution of other leading Jesuits, such as Lainez and Canisius
- the papacy, especially under Paul III and Pius IV, was committed to reform
- the Council of Trent, established by the papacy, also assisted reform
- the reform movement was underpinned by the operation of the new Orders
- monarchs were prepared to support the Jesuits and Catholic reform.

Good answers are likely to/may show an awareness of the interaction of factors, for example the contribution of Jesuit theologians to the Council of Trent.

**Question 3**

**05** Explain why the Anabaptists were persecuted. (12 marks)

*Target: AO1(a), AO1(b)*

**Generic Mark Scheme**

Nothing written worthy of credit. **0**

**L1:** Answers will contain either some descriptive material which is only loosely linked to the focus of the question or some explicit comment with little, if any, appropriate support. Answers are likely to be generalised and assertive. The response will be limited in development and skills of written communication will be weak. **1-2**

**L2:** Answers will demonstrate some knowledge and understanding of the demands of the question. They will **either** be almost entirely descriptive with few explicit links to the question **or** they will provide some explanations backed by evidence that is limited in range and/or depth. Answers will be coherent but weakly expressed and/or poorly structured. **3-6**

**L3:** Answers will demonstrate good understanding of the demands of the question providing relevant explanations backed by appropriately selected information, although this may not be full or comprehensive. Answers should include a range of reasons as to why Anabaptists were persecuted.

Students might include some of the following factors:

- Anabaptists suffered from 'guilt by association' on account of the events of the Peasants' War
- the authorities, both Catholic and Lutheran, were antagonised not only by the rejection of the sacrament of infant baptism, but they also disapproved of practices which they associated with Anabaptists, e.g. refusal to take oaths, the rejection of private property
- more radical Protestants wished to distance themselves from accusations of Anabaptism. This led to persecution in areas under Zwinglian influence
- the level of persecution was intensified as a result of the excesses of Münster
- strongly linked to supporting the poor/energising them (few middle class/noble supporters).

To reach higher levels, students will need to show the inter-relationship of the reasons given. For example, they might note that Catholics and Lutherans alike combined to destroy Anabaptism in Münster.

**Question 3**

**06** How important was the work of the Consistory to the success of the Reformation in Geneva to 1564? (24 marks)

*Target: AO1(a), AO1(b), AO2(b)*

Students should be able to make a judgement by addressing the focus of the question and offering some balance of other factors or views. In 'how important' and 'how successful questions', the answer could be (but does not need to be) exclusively based on the focus of the question.

Factors suggesting the importance of the Consistory to the success of the Genevan Reformation might include:

- the Consistory was responsible for setting high standards of religious observation and moral behaviour; policing of the latter became increasingly important
- the rules regarding social behaviour were tightened, and this enhanced the popularity of the Consistory amongst many – with an emphasis on consumer protection and protection of the weak
- it was closely linked to the secular power in that meetings were chaired by one of the Syndics and punishments required the confirmation of the Little Council
- creation of a ‘Godly’ community – admired by others.

Factors suggesting that other reasons were important might include:

- the emphasis on doctrinal coherence provided by the *Institutes*
- the ability of Calvin to overcome religious opponents
- Calvin’s destruction of political and religious opposition within Geneva
- his increasing political influence, especially from 1555
- the influence of the Genevan Academy as an educational institution
- Calvin himself doubted that moral behaviour in Geneva had been completely reformed.

Good answers are likely to/may show an awareness of the interaction between religious and political factors.
